



NOTES:

- 1) WOOD NAILERS OR WOOD BLOCKING FOR PENETRATIONS, CURBS, OR SNOW PROTECTION SYSTEMS SHALL BE INSTALLED PRIOR TO THE INSTALLATION OF THE ROOF MEMBRANE WHENEVER POSSIBLE.
- 2) VAPOUR RETARDER SHALL BE SEALED AT ALL SEAMS, PERIMETER AND PENETRATIONS.
- 3) CONTINUOUS CLEAT IS REQUIRED IF FACE DIMENSION OF FASCIA EXCEEDS 3".
- 4) FACE DIMENSION OF FASCIA SHALL BE A MINIMUM OF 3" OR AS OTHERWISE REQUIRED TO EXTEND A MINIMUM OF 1-1/2" BELOW BOTTOM OF WOOD NAILER.
- 5) THE HORIZONTAL FLANGE OF FASCIA SHALL BE A MINIMUM OF 4" WIDE.
- 6) FASCIA MAY BE FORMED WITH A OPTIONAL WATER DAM/GRAVEL STOP.
- 7) SCREWS USED TO ATTACH EITHER THE CONTINUOUS CLEAT OR FASCIA SHALL PENETRATE THE NAILER A A MINIMUM OF 1".
- 8) SEALANT IS A MAINTENANCE ITEM AND IS NOT COVERED UNDER THE ROOFPRO WARRANTY.
