- Not to be applied directly to polystyrene products
- Sarnafil® membranes are incompatible with asphalt, coal tar, heavy oils, roofing cements, creosote and some preservative materials

### APPLICATION

Sarnafil® S 327-60 EnergySmart is rolled out after proper preparation of the approved substrate and attached to the roof deck with appropriate mechanically-attached system with Sarnafasteners in accordance with Sika's technical requirements. Sarnafil® S 327-60 EnergySmart seams are heat-welded together by trained operators using hot-air welding equipment. Different mechanically-attached systems require different application methods. Please consult Sika's Specifications or Applicator Handbook for detailed installation procedures.

### MAINTENANCE

As a prudent preventative measure, Sika Canada recommends that the Owner or that the Owner's designated representative inspect the installed roof system for damage, flashings, plugged drains, weathered sealants, etc. at least twice a year and after each storm.
