This new line is the latest addition to the 3 operational production lines at the Boisbriand plant, which already produce a wide range of products, from masonry mortars to shotcrete mixes, in formats ranging from 17 kg bags to 1,500 kg FIBCs. This investment consolidates the production infrastructure for all Sika cementitious products on a single site in Quebec, thereby offering significant gains in terms of production volume as well as industrial equipment optimization.
